In addition, REDcert employees as well as auditors recognised by REDcert must be granted the right to conduct a special audit or a witness audit. Furthermore, the point of origin acknowledges that his name and address will be registered in the mandatory Union database (UDB) for the purpose of traceability of feedstocks.
